Code of Conduct for School Governors

Introduction

Research has shown that a Governing Body can make a difference to the overall quality of a school and can help to create the climate for effective teaching and learning to take place. Objectivity

We will act and take decisions impartially, fairly and on merit, using the best evidence and without discrimination or bias.

Accountability

We are accountable to the public for our decisions and actions and will submit ourselves to the scrutiny necessary to ensure this.

Openness
