Dates: Monday 14th June - Wednesday 16th June 2021

Cost: £168 - £180 (depending on number of children going).

The final cost will be confirmed in November once we know final numbers.

You may prefer weekly payments, which can be made of any sum convenient to you. Please contact Mrs Munt in the school office. If you feel you are not able to make these payments at these particular times or have any questions please do not hesitate to contact us.

We are hoping the current restrictions due to Covid-19 for residential trips will be lifted by the summer. The Department for Education are constantly reviewing their advice. If the trip is unable to take place due to Covid-19 restrictions, all money will be returned to you.
