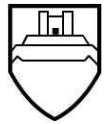

### **Year 5/6 Residential Trip to Hooke Court**

As you are aware, we had to re-arrange the 2020 residential trip to June 2021 for Year 5 and Year 6. Miss Crook will be leading the trip, supported by Miss Robinson.

In June 2021 we are planning to take the children on a residential trip to Hooke Court. Hooke Court is located near Beaminster, Dorset and stands in 14 acres of mature park and woodland.

The children undertake a busy programme whilst they are away, but please be assured this does not include any dangerous activities. They will learn new skills, get to know each other better and also learn to be more independent – hopefully!

**Cost: £168 - £180 (depending on number of children going).**

**The final cost will be confirmed in November once we know final numbers.**

You may prefer weekly payments, which can be made of any sum convenient to you. Please contact Mrs Munt in the school office. If you feel you are not able to make these payments at these particular times or have any questions please do not hesitate to contact us.

We are hoping the current restrictions due to Covid-19 for residential trips will be lifted by the summer. The Department for Education are constantly reviewing their advice. If the trip is unable to take place due to Covid-19 restrictions, all money will be returned to you.
